**ORDINANCE LEVYING AND ASSESSING TAXES OF
SOUTH ELGIN FIRE PROTECTION DISTRICT
KANE AND DUPAGE COUNTIES, ILLINOIS FOR 2025**

BE IT ORDAINED by the Board of Trustees of the South Elgin Fire Protection District, Kane and DuPage Counties, Illinois, as follows:

Section One: That the sum of **NINE MILLION NINE HUNDRED AND FORTY SIX THOUSAND AND FIFTY DOLLARS (\$9,946,050.00)** be assessed and levied from and against all taxable property within the limits of the said South Elgin Fire Protection District, as the same is assessed and equalized for State and Counties purposes for the current year, 2025, and are to be applied in liquidation of the appropriations heretofore made by Ordinance No. 2025-003 adopted by the Board of Trustees of the South Elgin Fire Protection District, at a meeting there of regularly convened and held on December 16th 2025 and duly published as provided by law and the specific amount hereby levied is set forth under the column entitled "Amount To Be Raised By Tax Levy," as follows:

**AMOUNT TO BE RAISED
BY TAX LEVY:**

CORPORATE FUND

Corporate Fund Levy \$3,714,000.00
The foregoing amount is hereby levied for general corporate purposes.

AMBULANCE FUND

Ambulance Fund Levy \$3,350,000.00

The foregoing amount is hereby levied for the purpose of providing emergency ambulance service under and pursuant to the provisions of 70 ILCS 705/22.

EMERGENCY/RESCUE FUND

Emergency/Rescue Fund Levy \$675,000.00

The foregoing amount is hereby levied for emergency/rescue expense purposes pursuant to the provisions of 70 ILCS 705/24.

BOND AND INTEREST FUND

Bond and Interest \$705,550.00

The foregoing amount is hereby levied for the purposes of repayment of bonds pursuant to the provisions of 70 ILCS 705/13.

PENSION FUND

Firefighters' Pension Fund Levy \$1,501,500.00

The foregoing amount is hereby levied for firefighter's pension fund purposes under and pursuant to 40 ILCS 5/4-118. Included in this levy amount is the sum of **\$136,500.00**, which is directly attributable to Public Act 93-0689 and is this exempt from the PTELL calculation.
