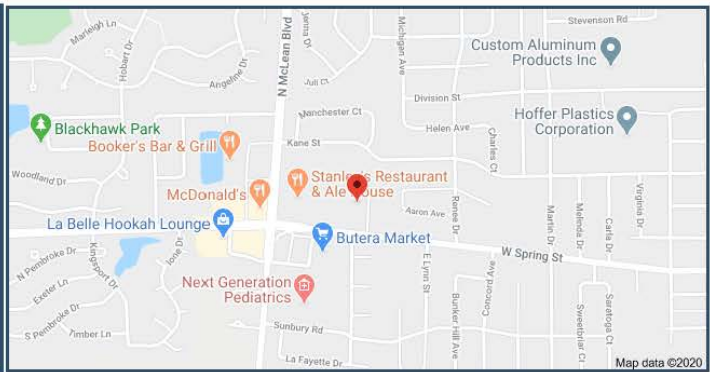

South Elgin & Countryside Fire Protection District currently operates out of three fire stations located uniformly within the District to help us serve our residents better!

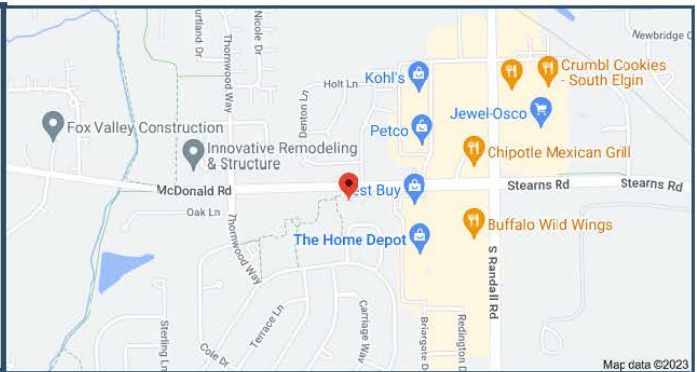
We moved into our newly built District Headquarters Station 21 in July of 2020. Station 21 houses the administrative offices and is located at 1090 W. Spring Street.

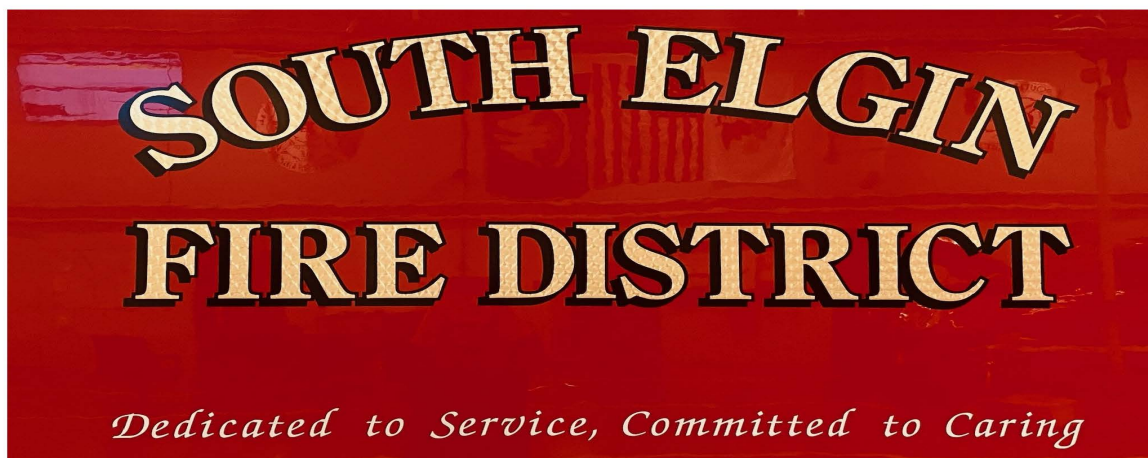


Mission Statement

LETTER FROM THE CHIEF

Fire Chief William J. Luchsinger

It has been many years since the South Elgin and Countryside Fire Protection District has published an Annual Report. I am pleased to share this 2022 Annual Report as we bring back this beneficial document for the community. Please review this report in its entirety as we share some valuable information such as our response times, incidents by districts, call volume by time/day, annual treasurer's report, personnel and so much more.

The South Elgin and Countryside Fire Protection District experienced a lot of changes and major reorganization throughout the 2022 year, all the while setting yet another record year of incidents. First, I would like to take this opportunity to recognize the retirements and personnel that left the Fire District. Fire Chief Steve Wascher retired on June 30th, 2022 after serving the Fire District for nearly three decades. The District also celebrated the retirement of Assistant Chief Mike Rothecker on February 10, 2022. During Chief Wascher and Assistant Chief Rothecker's tenures, our Fire District saw some of the most impactful and significant changes in our history. The addition of a third fire station, new headquarters station and the hiring of additional full-time staff were some of the major accomplishments. The changes implemented under Chief Wascher and Assistant Chief Rothecker have placed the District in a position for success and ready to accept any challenge the community may present us with.

The District also celebrated the retirements of Firefighter/Paramedic Steve Diehl on January 28, 2022, and Firefighter/Paramedic Walter Antos on June 17, 2022. Collectively, the District lost a combined 110 years of institutional knowledge and experience with these four retirements. On a positive note this created opportunity for the District, as we place new personnel into leadership roles and hire new, younger eager staff. We were also able to hire a very experienced Assistant Chief. In August of 2022 the District hired Assistant Chief Dave Schmidt. Assistant Chief Schmidt served the Elgin Fire Department starting as a firefighter and working his way through the ranks before retiring as the Elgin Fire Chief. Upon retirement, he spent three years as the Fire Chief of Carrboro, North Carolina before returning back to the area. Assistant Chief Schmidt brings four decades of experience and knowledge to the leadership team as we continue to transform and improve the District.

The District sponsored ten candidates to the Elgin Community College Basic Operations Firefighter program. Those ten candidates graduated from the ECC BOF academy in December at which point they returned to South Elgin and began a vigorous in-house boot camp to learn the ways and methods of operations of the South Elgin Fire District. Boot Camp training included ambulance driving, emergency medical skills, tool familiarization and location, as well as fine tune their firefighting skills.

During the 2022 year the District put out a request for proposals to seek a new auditing firm. After many years with the current firm, they notified the District that the firm was no longer servicing fire districts. After following the RFP process, the District Board secured a three-year engagement with Sikich Inc. to conduct the audits of the corporate, pension and Foreign Fire Insurance funds.



The District exhausted its full-time eligibility list as a result of the many retirements. The District conducted interviews and testing to create a new full-time eligibility list in accordance with Illinois state laws. With immediate openings that needed to be filled the District completed the testing process and posted our new full-time list in November. Two new full-time employees were immediately hired, and a third shortly after the first of the year in 2023. The current full-time list is set to expire November 15th, 2024, unless either exhausted or extended by applicable law.

Our Fire District nor the fire service in general are not immune to the current financial market of cost increases and purchasing delays that everyone is seeing on a regular basis. The District saw increases in our fuel costs, operating costs, as well as equipment purchasing. In June of 2022, the District placed an order for a new ambulance; delivery isn't expected for two years. This current environment of supply and vendor issues makes planning difficult. However, the District has taken and will continue to take action to minimize the impact of these supply and purchasing delays and ensure the community is always protected with readily available emergency equipment. Our very own in-house maintenance department does an amazing job keeping our fleet of fire suppression apparatus, ambulances, support and staff vehicles in a state of readiness.

The District adopted its fiscal year 2022/2023 budget, but with a minor change, compared to years past. The District use to operate a singular annual budget and all revenue and expenses were funneled through that budget. Starting in June of 2022, the District adopted a new budget process with an Operational, Capital Expenditure, and Economic Stabilization Budget. This practice will help the District plan for long term purchases as well as create an opportunity to weather any fluctuations in the financial industry while also maintaining an operating budget. A single budget dedicated to operations provides for better opportunity to assess and adjust operations upon evaluation and need.

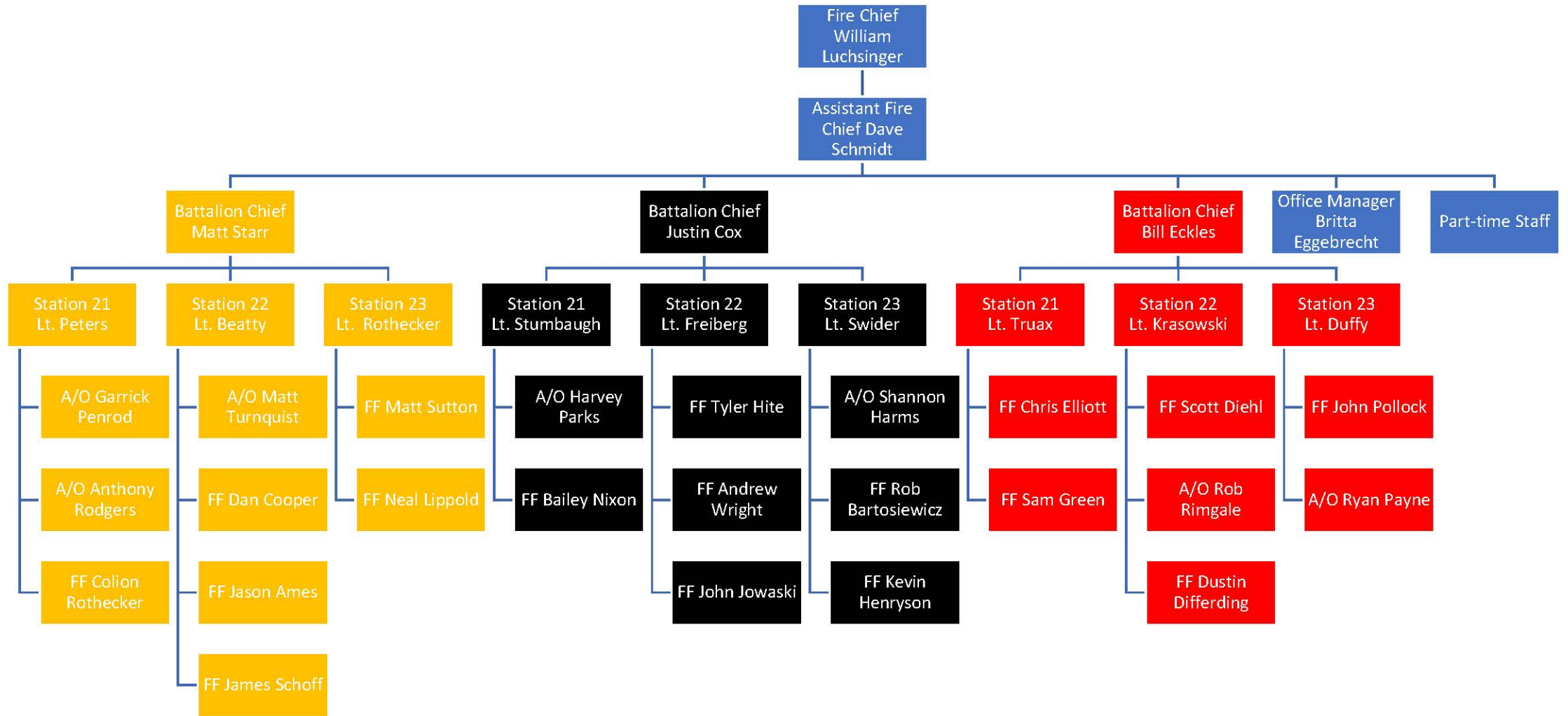

2022 call volume shows that the District responded to 3,756 requests for service, slightly above 2021. In January 2022 the District stopped responding to “trouble alarms.” These are alarms that simply indicated that there were non-operational faults in fire and sprinkler alarms.

Those alarms do not report fires or smoke in buildings as those are true “fire alarms.”

Trouble alarms typically indicate such things as low batteries, cold temperatures, low air, pull station faults or other similar topics. All such things that our crews do not even have the ability to correct or mitigate. In 2021 the District responded to approximately 200 trouble alarms. With the elimination of the trouble alarm response, the fact that we maintained relatively the same number of responses indicates our District is growing on a regular basis.

With the amount of growth we continue to see within the Village of South Elgin and the Fire District, we can expect to continue to see the call volume increase.

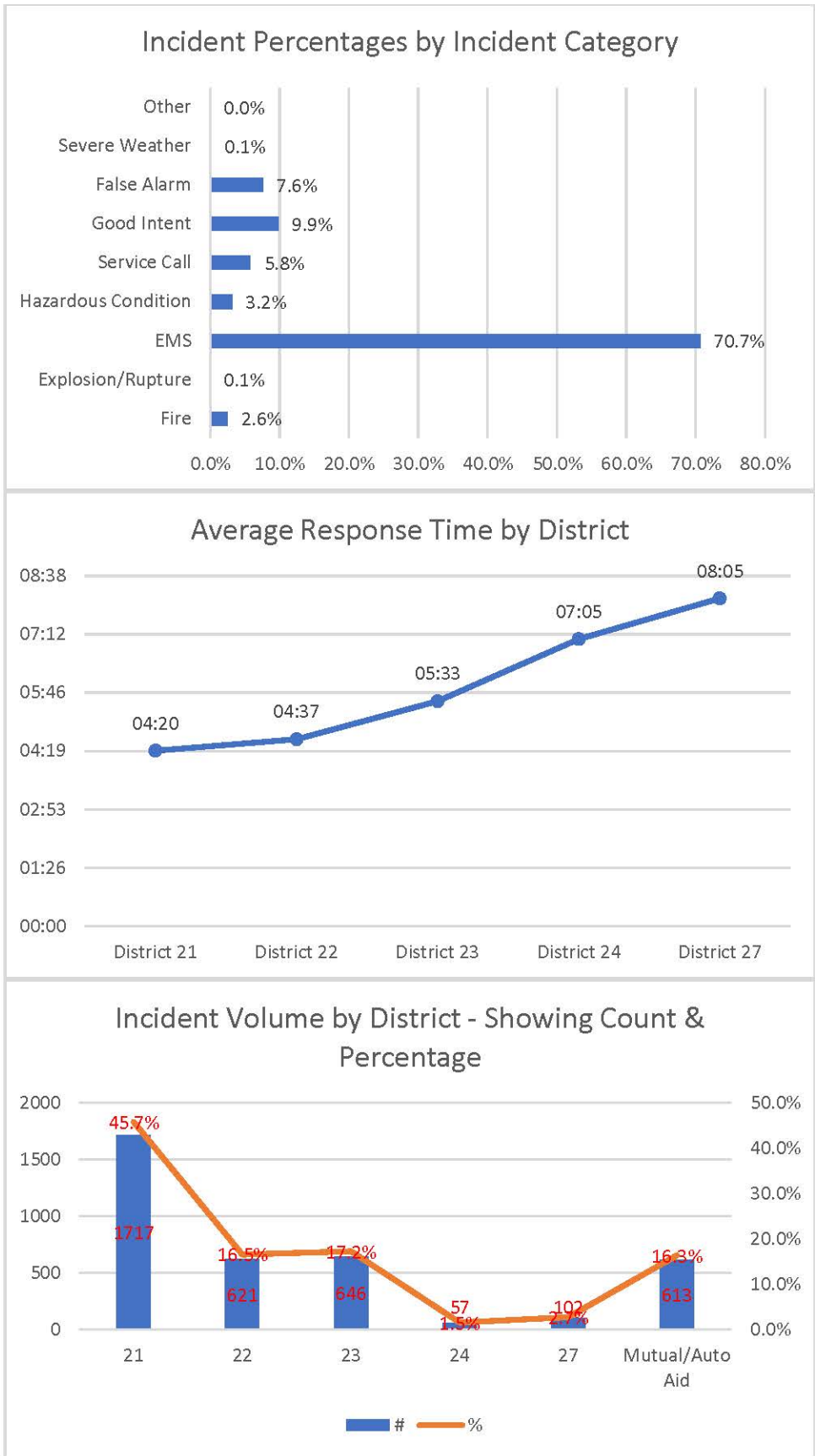

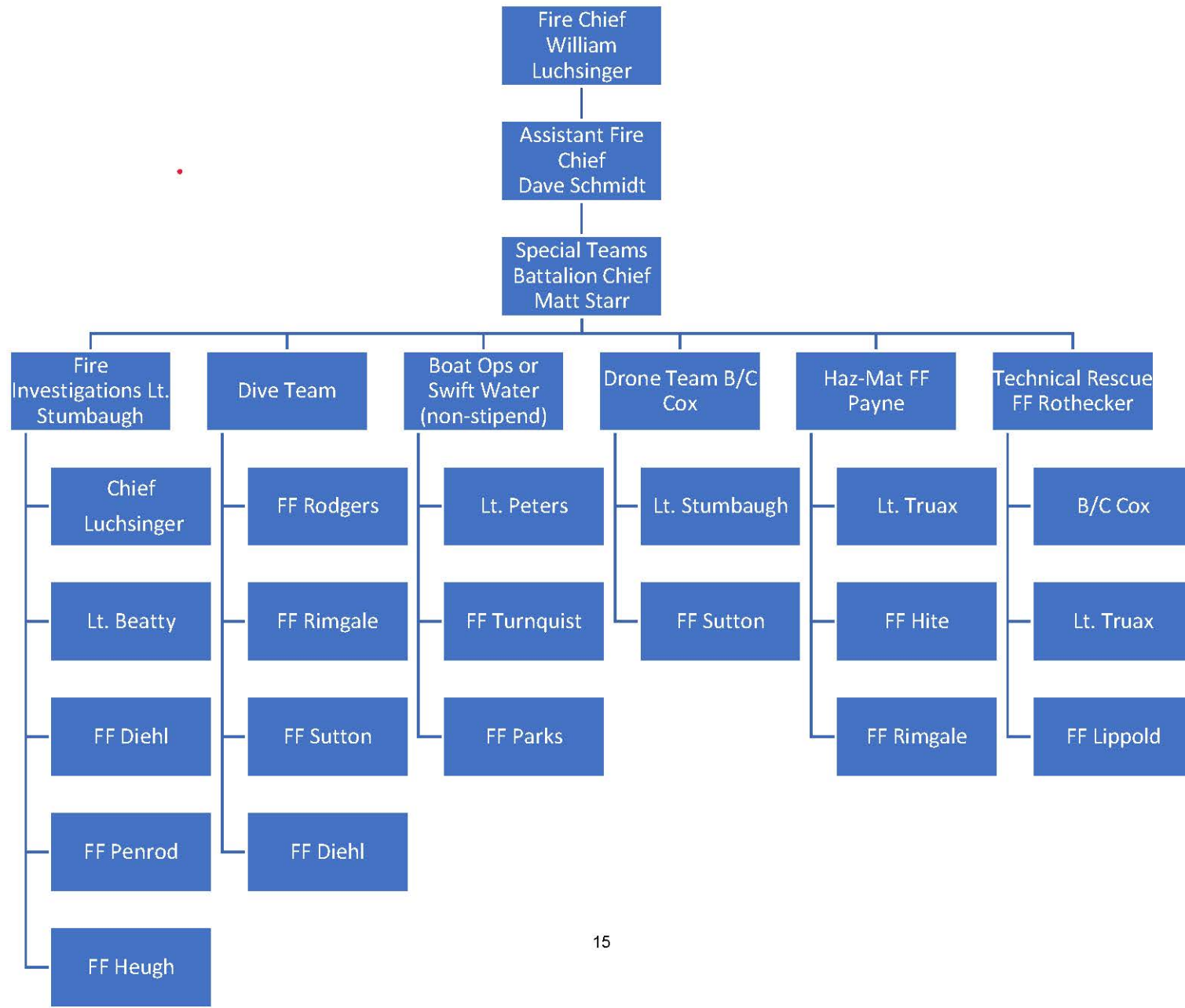

DIVE TEAM

For almost four decades, the South Elgin & Countryside Fire Protection District has been in operation serving locally and providing support to surrounding communities in public safety diving. The SECFPD Dive Team started in 1982 as a way to respond to civilian assistance and rescue in the Fox River, creeks, ponds and small lakes located within our district's boundaries.

The Dive Team for the South Elgin and Countryside Fire Protection District consists of 6 members; four of the members are Dive and Swift Water certified and two members are Boat Operators only. Firefighter/Paramedic Rodgers took over the team lead position when Firefighter/Paramedic Steve Diehl retired on 02/11/2022. In 2022 the team was dispatched/called out 9 times including out of town and MABAS call outs. We had two members help a local Eagle Scout with an Eagle Project, placing fish cribs in the East Avenue Park Pond. MABAS meetings were stopped in 2020 due to covid and resumed in 2023. With COVID limitations behind us and new leadership in place, some goals that the Dive Team will be working on is to replace old outdated and damaged equipment as well as becoming more involved in training.



EMS Division 2022

South Elgin's EMS Division is responsible for the licensure of ambulances, paramedic equipped fire engines, medical equipment and supplies as well as maintaining continuing education for all personnel. We currently have 3 ALS ambulances, 2 ALS fire engines, and 1 BLS utility terrain vehicle (UTV). Also, relationships with our EMS System, Project Medical Director, and Illinois Department of Public Health are managed by our EMS Division.

We experienced even more challenges by the COVID-19 worldwide pandemic that continued into its third calendar year. COVID continued to test our resources and personnel. Once again, and with more confidence, we answered these calls with professionalism and compassion. The department and EMS Division worked closely with state, regional, and local authorities to ensure that our PPE was adequate, our protocol was appropriate, and we were current on the latest trends and guidelines.

We sent and sponsored four of our Emergency Medical Technician – Basic's (EMT-B) to paramedic school. This is a very hard 1-year advanced medical training that requires an enormous amount of schooling, clinical hospital time and in-field clinical time to obtain the national and state level certification. This provides the best advanced care within our scope of practice to better treat our citizens. All four firefighters graduated with honors!

Our EMS division has implemented programs for our medical report writing, ambulance inspection / inventories, and controlled substance documents to be paperless! We also purchased a state-of-the-art EMS training mannikin that is computer controlled to enhance the levels of trainings to better our skills.



Fire Investigation Team

Fire investigations are a vital component of compiling accurate fire origin and cause. These determinations are essential in protecting the lives and property of our District's residents, businesses, and visitors, and to prevent future incidents.

The South Elgin & Countryside Fire Investigation Team investigated 13 major fires in 2022. The team consists of 6 members, with two new investigators joining the squad. The team is a member of the Kane County Task Force, which is made up of area fire departments, police departments, the Bureau of Alcohol, Tobacco, and Firearms, and the State Fire Marshals Office. The District's team joined the Fire Investigators Strike Force at the end of 2022. The Fire Investigators Strike Force is a nonprofit association of fire investigators that provide an ongoing source of training on current topics and advancements in the science of fire investigation. The team started using Image Trend for reporting and documentation when the District made the decision to combine their EMS and incident reporting.

FIRE PREVENTION

The South Elgin Fire Protection Bureau is responsible for the coordinated efforts of safety inspections, development activities, public education, and CPR. Coming out of COVID restrictions the Bureau was able to get back in the field and have contact with local business owners, residents, and students. Working with the Village of South Elgin Community Development Department our Bureau worked on the planning of new developments within multiple industrial, commercial, and residential districts. Inspector Zabran welcomed and inspected many new businesses to the community in 2022.

On October 8th the District hosted an Open House for the Community. This was the first time in many years that we were able to have an event where the public could come and tour the new Station 21. Activities such as Special Teams, CPR, fire extinguishment, tours, and firefighter meet and greet were provided. Outside community organizations were also present to talk about services they provide. The few hundred residents/visitors poured in and made this event a huge success!

The Fire Prevention Bureau is actively working on different types of developments within the Village of South Elgin. Projects are being worked on in different phases of development, starting with the planning phase, then moving on to the plan review phase, and finally finishing with the inspection phase.

HAZMAT TEAM

The South Elgin & Countryside Fire Protection District's HAZMAT Team members are professionally trained and certified to decontaminate areas exposed to dangerous materials. Hazardous materials response (HAZMAT) teams are the first line of defense in situations dealing with "hazardous materials," which refers to any substance that poses a significant risk to people, property, or the environment. HAZMAT teams are deployed to deal with spills, leaks, and other accidental releases of these materials.

In 2022 the South Elgin Fire District's HAZMAT Team responded to more than 40 calls. These calls involved gas leaks, CO alarms, and other hazardous chemicals. South Elgin Fire District is the home of the Division 2 HAZMAT Team trailer. Members of our team responded to five calls this year for Division 2 necessity. During the year the department HAZMAT Team has worked and trained with a number of different agencies including the neighboring fire districts, as well as Canadian Pacific Railway, and the FBI Field Office of Chicago.

STATION MAINTENANCE

South Elgin & Countryside Fire Protection District takes a great deal of pride in our three fire stations. South Elgin Fire District currently operates out of three fire stations located uniformly within the District to help us serve our residents better!



We moved from our old Station 21 at 150 W. State St. into our newly built Station 21 located at 1090 W .Spring St. in July of 2020.

Station 22, built in 2002 is located west of Randall Road at 2055 McDonald Road.



The District was very excited to have added a third station in April of 2020. Station 23, located at 498-A South Elgin Boulevard.

Our very own firefighters do an amazing job keeping our stations clean and well maintained. Each fire station has a firefighter in charge of their station's maintenance, with a Battalion Chief overseeing all. Not only do the stations need routine maintenance, they also require annual / preventative testing on our extinguishers, HVAC systems, hood testing, RPZ valves, elevators and sprinkler systems. Routine maintenance includes sustaining the cleaning and station supplies that we need for day-to-day operations and making repairs or arranging repairs on anything in current need .

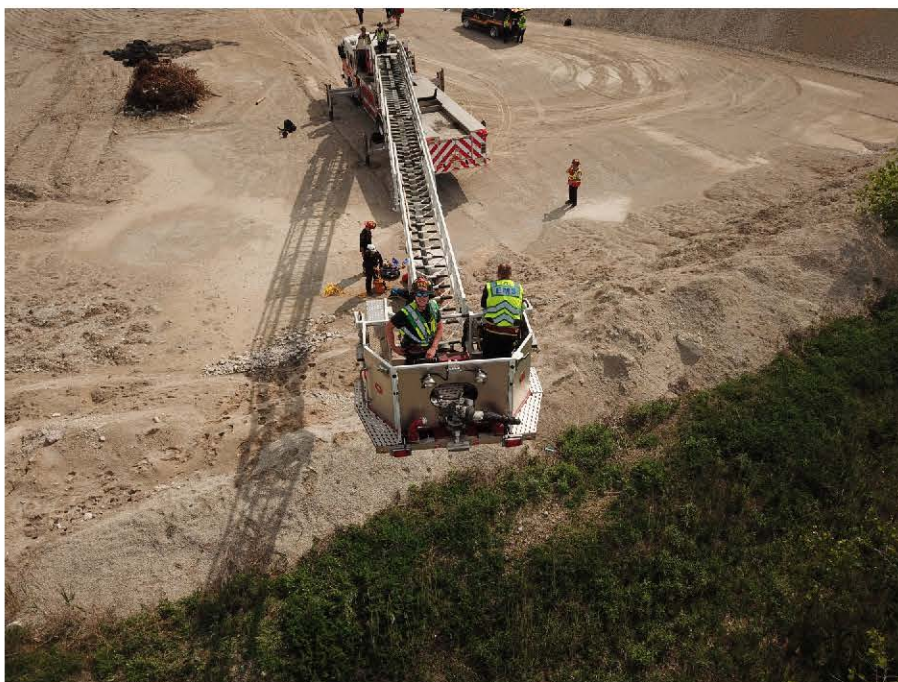
A few station maintenance items performed in 2022: repairs on the plymovent, replaced ceiling tiles, drywall repair and painting, installed a new key pad on the employee entrance, a new sump pump and countless little repair/replace jobs!



Technical Rescue Team

The Technical Rescue Team's members are trained to respond to specific special rescue situations including rope rescue, confined space, structural collapse and trench rescue. All team members are required to complete annual training in each of these four disciplines.

The South Elgin Technical Rescue Team currently has four members on the deployment roster, BC Cox, Lt Truax, FF/PM Lippold and Lt Mike Rothecker, who is also the team leader. South Elgin hosted 3 of the Division 2 team's drills in May, September, and November, consisting of slope rope rescue, structural collapse, and elevated rope rescue. The District would like to thank Lafarge Quarry and Welch Brothers for their generosity in partnering with our team and allowing us to use their property to conduct drills for our training. The team in total combined for approximately 116 hours of TRT training. Three of our members also participated in a MABAS deployment drill in Frankfurt in April.
